Registration/Waiver

- This photography workshop will be conducted regardless of weather conditions.
- A \$100 non refundable deposit is required. The deposit will be applied towards the workshop fee.
- Workshop fee is \$200 if paid in full by March 31, 2010. After April 1, 2010 the workshop fee is \$250.
- All workshop attendees must abide by Private, Traffic, City, County, State, and Federal laws, rules, and ordinances. This includes, but not limited to park lands in City, County, State, Open Space, Regional, and National Parks, public and private educational institutions.
- Attendees are responsible for all their meals, lodging, transportation, and parking/entrance fees.
- I understand that participating in this event is potentially hazardous, and that I should not enter and participate unless I am medically able and properly trained. In consideration of the acceptance of this entry, I assume full and complete responsibility for any injury or accident which may occur while I am traveling to or from the event, during the event, or while I am on the premises of the event. I also am aware of and assume all risks associated with participating in this event, including but not limited to falls, contact with other participants, effect of weather, traffic, conditions of the road, and contact with wildlife.
